Dear Parent:

Thank you for your interest in registering your child for participation in the TCS Discovery Education “Ignite Innovation Student Challenge” (the “Contest”), a national contest in which students in Grades 6 – 8, working alone or in teams of up to four students, will be challenged to create a digital solution that solves a problem in one of these areas: Health, Our Planet, or Education.

To participate in the Contest, your child (together with his/her teammates, if entering as a team) must create a one- to two-minute video that addresses the challenge outlined in the contest entry information. The entry may contain your child's likeness, image, voice or other identifiable features.

The judges will consider the creativity, content, persuasiveness and effective communication, and overall presentation of the entries. Top prizes include up to a \$10,000 scholarship and the chance to work with TCS to make their idea come to life. What do you need to do?

In order for Discovery Education, Inc. (“Discovery Education”) to consider your child's entry into this Contest, you must agree to the terms of this Consent Form by providing us with your electronic signature. To do this, simply type your first and last name in the fields below to indicate that you agree to the terms of this Consent Form and the Official Rules and that you understand that you and your child will be bound by this Consent Form and the Official Rules. After typing your name in the fields and providing any other requested information, if you are the parent of an individual entrant or student team leader, create a user name and password, and click the "SUBMIT" button below. The form will then be automatically sent to Discovery Education. If you are the parent of a student team member who is not the student team leader, provide this completed form electronically to the student team leader, who will then provide the form to Discovery Education along with the team's entry. **YOUR CHILD WILL NOT BE ABLE TO PARTICIPATE IN THE CONTEST WITHOUT YOUR CONSENT.**

Your Consent

By signing this Consent Form, you agree to the following terms and conditions:

(1) You, as parent or legal guardian of the student named below, have read and understand this Consent Form and hereby permit your child to participate in the Contest. Further, you and your child agree to be bound by the [Official Rules](#) of the Contest and the terms of this Consent Form. In the event of any conflict between the Official Rules of the Contest and the terms of this Consent Form, the Official Rules of the Contest shall prevail.

(2) You and your child understand and agree that his or her participation is voluntary and that Discovery Education will be collecting personally identifiable information about your child in order to administer this Contest. This personally identifiable information may include your child's first and last name, date of birth, home address, email address, phone number, grade and school ("Personal Data"). You understand and acknowledge that the Personal Data will be used in accordance with Discovery Education's privacy policy located at <https://www.discoveryeducation.com/who-we-are/privacy/>, and that by participating, you and your child agree to be bound by this privacy policy, provided that in the event of any conflict between the Official Rules of the Contest and such privacy policy, the terms and conditions of the Official Rules shall prevail.

(4) You and your child further grant to Discovery Education the permission to publish and display your child's Entry, or excerpts or portions of his or her Entry, on its external web site, so that they may be viewed by the public in correlation with this Contest.
